School Boards Congratulate Saskatchewan Party Government

The Saskatchewan School Boards Association congratulated Premier Brad Wall and the Saskatchewan Party on forming another majority government in April's election.

"During the Sask. Party's first two terms in government, we built a relationship around priorities for education in our province, including through the first-ever Education Sector Strategic Plan," SSBA President Connie Bailey said. "We know the government shares with elected school boards both a commitment and a responsibility to students, families and communities in Saskatchewan. We look forward to continue working with the government to support achievement for all of our children."

Bailey also congratulated all newly elected or re-elected MLAs who won in their constituencies on Monday and thanked all who put their names forward on the ballots. She recognized in particular the successful candidates for both parties with backgrounds of service as elected school board trustees.

"Trustees in this province are locally elected to bring the voice of

Regarding priorities for working with the government going forward, Bailey noted she looks forward to results of a review of the education funding formula that began in 2015.

President's Address to Spring General Assembly

Good evening and welcome to our Spring General Assembly.

Thanks to all of you for being here tonight and for your commitment and leadership in supporting achievement for all students in our province.

As you know, the SSBA, as a democratic and voluntary organization, ensures advocacy, leadership and support for member boards of education by speaking as the voice of public education, offering opportunities for trustee development and providing information and services.

With 28 unique and autonomous boards of education this can sometimes be a challenge – but that is where our structures, bylaws, governance and processes serve us well. Through resolutions, our Vision 2025 strategic plan, alignment with ESSP and multiple forums for input and direction, we are able to land on some shared priorities – and it is these I want to focus on.

One of the objectives of the SSBA is to promote the work and importance of locally elected school boards. We can be proud of the fact that our organization, along with our partners in education in Saskatchewan, continues to demonstrate that, through partnership and collaboration, we can provide the best possible educational opportunities and

outcomes for all students.

It is my privilege to serve as president of an Association that represents separate, public, francophone, Aboriginal, urban and rural leadership within education. And while this can present challenges at times, when I travel as part of the CSBA national work – I can tell you that what Saskatchewan has continues to be a model that others wish to emulate.

This is a big year in Saskatchewan – with the provincial election just behind us and municipal and school boards to come this fall. These elections are excellent opportunities for the SSBA and all of us to remind our communities, those running and elected to office and the broader public of the important role of boards of education.

The SSBA is using every opportunity to highlight that locally elected school boards have a vital role in serving Saskatchewan's publicly-funded education system and that the longest lasting and most fundamental responsibility of schools boards has been to bring the voice of the public to publicly-funded education.

We also highlight that collectively, the women and men who are locally elected to serve on Saskatchewan's boards of education are committed to serving children, youth, parents and communities.

Another objective is to advocate for funding that adheres to the principles identified by members.

With the current economic situation our province faces, it is critical, now more than ever, to emphasize the importance of education, and the work we do on

behalf of students, communities and for the betterment of society and this province. You might say that education, though probably not recognized as such, is the most critical economic driver.

While school boards have always found savings and efficiencies, I believe there is a renewed spirit of cooperation in finding efficiencies throughout our sector and making sure we are meeting the needs of our students while being mindful of fiscal responsibility. But only focusing on efficiencies is not going to address the challenges of growth and the changing student needs across this province.

Education funding, as we highlight in our principles, is about the bigger, long-term picture.

Education is crucial to ensuring the next generation are the critical thinkers, the innovators, the leaders, the entrepreneurs, the employers and the workers.

We, in many ways and across many fronts, work closely together with the provincial government to ensure our students have the resources and supports they need to succeed. It is imperative, and incumbent upon us, to make sure

→ we are collaborating with the government in partnership, and to make sure views of locally elected school boards are reflected in government decision-making and vice versa.

So, even when times are tough, we must continue to champion the crucial importance of education in ensuring our society's members have the skills and abilities they need to contribute to the economy.

But more importantly, we must champion our education system as a system of hope, as a system of change and a system of the future.

We know that a review of the funding model for education is underway in our province.

We continue to be supportive of that work and hopeful that it will result in a system for funding education that meets the principles you as our members have identified as critical for education funding throughout Saskatchewan. Another important objective for our organization is supporting key initiatives focused on First Nations and Métis education and improved student achievement in our province. This year our plan includes support for the transition of the **Aboriginal Youth Employment** Program in Saskatchewan to an organization or school division best suited for the program delivery.

We will also continue to profile and incorporate First Nations and Métis education information and success in SSBA activities and communications materials.

This year a priority focus, one that it shared with all levels of government and organizations across this country, is how we can

act on recommendations of the Truth and Reconciliation Commission. One of the recommendations focuses on curriculum and the SSBA is currently in the process of commissioning the development of a FNME/Residential Schools Position Paper to guide our actions and response.

The SSBA also continues to support the Education Sector Strategic Plan, which was agreed upon in 2014 by boards and the Ministry of Education. One of the priorities of this plan includes improving engagement and outcomes for First Nations and Métis students in our province.

Our organization does a lot of supporting. Just how our Association provides support is highlighted in another important objective and that is to increase awareness of the services and value provided by SSBA. We know from our research that the services the SSBA provides to its members are well-used and appreciated. Success for each of our province's 28 boards is in part achieved through the support and services provided to members.

As an Association, we are able to collectively achieve cost savings and unified and consistent approaches where it makes sense. This is now as important as ever to keep in mind as we demonstrate how boards across the province always seek to find efficiencies – particularly during this time of fiscal restraint.

The SSBA will continue to look for ways and opportunities to enhance our ability to bring our members together, understand the issues we face individually and collectively, share information and best practices and ensure we can speak with a united voice. Thank you.
