\$100,000 Announced for 10th Anniversary Mosaic Challenge

To celebrate the 10th anniversary of the Mosaic Extreme School Makeover Challenge, The Mosaic Company has provided \$100,000 in total cash prizes for 2016, Mosaic, the Saskatchewan School Boards Association (SSBA) and Breakfast for Learning (BFL) have announced.

"In honour of 10 years of successful partnership with BFL and the SSBA, we want this year's challenge to leave a lasting impact on children across the province," said Sarah Fedorchuk, Senior Director of Public Affairs for The Mosaic Company. "We are excited that schools and communities get to pick the project that will net the biggest returns for their kids. Mosaic plays an important role in food security around the world; here at home we understand that quality nutritional programming is imperative to achieving success in the classroom."

Together with the SSBA and BFL, Mosaic launched the Extreme School Makeover Challenge in 2006. To date, 23 schools have received funds to improve nutrition environments.



Partner Announcement at Spring Members' Council in Regina

The Mosaic Extreme School Makeover Challenge is open to all schools in Saskatchewan.
Participating schools receive a certificate of recognition acknowledging their efforts to create healthier school nutrition environments.

Ten winners will each receive a \$10,000 prize. Schools are invited to submit nutrition-related action plans prior to Apr. 16, 2016. Entries will be judged on quality of nutritional

programming and potential benefits to the school community.

"Our students are our future leaders, and investing in their learning through nutrition programs is vital to their success," said Kelly Berlinic, Director of Programs and Community Development for BFL.

"Breakfast for Learning is proud to work with the Saskatchewan School Boards Association and The Mosaic Company to ensure all

President's Remarks to Spring Members' Council

CONNIE BAILEY SSBA PRESIDENT (as presented on Feb. 4, 2016, at the DoubleTree by Hilton Hotel, in Regina, Sask.)



Good evening and welcome to our Spring Members' Council.

I know that recent events in the community of La Loche are top of mind for all of us in the education sector and in this province at this time. On behalf of the SSBA, I want to offer my sincere condolences to the community of La Loche and all affected by this tragedy.

I also want to recognize the strength of the community and extend my thanks to all those who have reached out in support from across the province, country and beyond, including local, provincial and federal governments, the RCMP and emergency services and the education sector across the province. We at the SSBA will continue to do everything we can to support the community and we know you will do the same.

I want to take this opportunity to observe a moment of silence for those who lost their lives in the tragedy that has affected this community, our province and indeed the whole country.

Thank you.

As we begin our Spring Members' Council this evening, keeping those impacted by the recent tragedy close in our hearts, I am reminded of why we come together as boards of education, and as a sector – it is because we are leading and doing important work for the students of

this province. And we share this responsibility with many partners.

I would now like to take a few minutes to share some thoughts with the group about the ongoing work of your Association before we move into the rest of our program for the evening.

I want to begin by commenting briefly on education in the context of the current economic situation our provinces faces.

We all know there are challenges in our economy, but we have faced this before. I would like to recognize that for school boards, while they have always found savings and efficiencies, I believe that there is a renewed spirit of cooperation in finding efficiencies throughout our sector and making sure we are meeting the needs of our students while being mindful of our commitments to fiscal responsibility.

At the same time, it is critical probably now more than ever to emphasize the importance of education, and the work we do on behalf of students, to the economy of our province.

Education is crucial to ensuring the next generation are the critical thinkers, the innovators, the leaders, the entrepreneurs.

Our students, our children must be engaged as successful and productive contributors to our society and our economy.

So, even when times are tough, we must continue to champion the crucial importance of education in ensuring all members of our society have hope and opportunity and the skills they need to ensure the growth of our province as a whole and in particular, its economy.

We continue to remain firmly committed to the belief that all children should have access to the resources they need to achieve, regardless of where they live in the province or personal circumstances.

We know that a review of the funding model for education is underway in our province and we continue to be supportive of that work and hopeful that it will result in a system for funding education that meets the principles of transparency, autonomy, predictability and equity.

Not until we are clear with the formula can we then understand if we indeed have resources that are sufficient and sustainable. These are what you as our members have identified as critical for education funding in our province.

As you know, this will also be a very busy year politically in our province and sector, with a provincial election this spring and school board elections this fall.

More information will be forthcoming in relation to both of those elections, but for now let me assure you that your Association is working to ensure that the goals and directions approved by our

Dec. 3 & 4, 2015

The Executive approved the 2016 Executive Workplan, reviewed the Board Chairs (or designate) Council Meeting Notes and the 2015 Adopted Resolutions Workplan. The Executive also received a financial update, the Good Practices and Dispute Resolution Committee progress update and the AYEP update.

The Executive had an opportunity to review and debrief feedback from the very successful and productive 100th Anniversary Fall Assembly.

In the round table discussions, some of the subjects included were: updates from the Infrastructure Committee, the Task Force on Teacher/Student Time and Workload Intensification, Aboriginal Council, CEF, MEPP and Catholic Section, and highlights and updates from the President and Executive Members' attendance at recent events.

Jennifer Tupper, Dean of Education, University of Regina, appeared as a delegation.

Jan. 21 & 22, 2016

The Executive approved decision items regarding: clarity and changes to 2016 AGM guest invitations practices based on SSBA bylaws; review of the Executive Policy Handbook; revised Employee Benefits Plan Advisory Committee Terms of Reference; CCSTA membership; addition of business portion at the 2016 Spring Assembly; creation of a FNME/Residential Schools Position Paper; and 2016 Elections Advocacy actions and messages in support of the Communications and Advocacy Plan.

The Executive Meeting began with a wall walk to update and discuss progress on the SSBA 2016 Strategic Plan.

Open Letter: Upcoming Provincial Election

With the provincial election coming, on behalf of the SSBA Executive and our members, school boards in our province want to take this opportunity to highlight our shared priorities for education in Saskatchewan.

We are all aware of the economic challenges our province is facing. As school boards, we are also aware of the challenge of balancing financial resources and providing much needed services. Boards of education have always tried to find efficiencies in order to optimize our resources. We continue to examine our own systems and work in cooperation with other partners to ensure that we are meeting the needs of our students.

At the same time it is critical, perhaps now more than ever, to emphasize the importance of education to our society. Our students will shape our province today and into the future. As Saskatchewan grows and changes, we must focus on renewal, and education must remain a top priority to ensure our students have the resources they need to be successful.

The longest lasting and most fundamental responsibility of schools boards is to bring the voice of the public to publicly funded education.

We continue to remain firmly committed to the belief that all children should have access to the resources they need to achieve, regardless of where they live in the province or their personal circumstances.
