I hereby agree that I will accept full responsibility for any damage, injury or loss caused to persons or property arising from my child's conduct.

I agree that the supervisors of the activity/trip may require my child to return home if a breach of those rules occurs and I agree to be responsible for and pay any and all costs that may arise. I further acknowledge that my child may be subject to school discipline if my child breaches rules during this activity/trip.

I accept that it is my responsibility to ensure that my child has adequate out of province medical coverage and insurance for loss or damage to personal property which may include student insurance. I agree that there may be costs associated with the recovery, transport and treatment of my child if my child is injured while travelling or while engaging in the activity/trip. I hereby agree to be responsible for and pay any and all such costs that may arise.
