Thank goodness for CJ Huff who actually WAS GREAT. I have heard Gary Meratsy will be good but I am not sure I can hang on. Conference needs to be at a hotel. Back and forth is a pain.

5.	I was glad to hear many of the sessions; Particularly Gary Merasty and the success stories for FNMI initiatives in the province.
	I would have liked to see the FN education organizations attend as well.
6.	Unfortunately due to the timing, I was unable to attend most of the conference. With the SSBA AGM being the two days before, it is difficult to dedicate 4 days to a conference. The schedule was not a good use of time. The idea is nice and I'm sure the speakers were good, but there needs to be a better way to use the time and perhaps shorten the time.
7.	While there was ample time between sessions to network informally, formal facilitated networking sessions on prescribed topics would be more useful for more purposeful collaboration and dialogue (questions 3 and 4). These could be linked to the presentations to support deeper learning and reflection on what we hear.
	I like the idea of a joint conference and would like to see it offered again but it was a little unwieldy to use every year. Our Director was unable to attend much of our AGM because he was involved in training modules with LEADS. It also extends the length of the conference which makes it more difficult for some trustees to get enough time away from work/life to attend.
	Is there opportunity to use technology to add efficiency to the voting and tallying process such as electronic voting? Someone else mentioned that most schools have remote "clickers" for taking surveys that might have some applications for voting. Just a thought!
	Overall, it was a very good event and thank you to all the staff who work hard to make it

so!

8. The trade show should be longer. It was very rushed and people had to make a choice between going for supper and seeing the trade show. Not fair to the vendors who travelled to show their products. Also allow for those not in attendance at the time of drawing to receive prizes. If they made the effort to go to 40 vendors they put in great effort. Their time following that may have been important time networking with others not waiting for draws so why not reward them for that.

The students in the panel were excellent. Consider involving more school divisions in student panels in the future.

I was disappointed in the lack of time the Ministers were willing to give us and the lack of questions trustees had for them. All should be ashamed of their lack of caring enough on this important topic that could have been great.

I was hoping Dan Perrins was going to get into some more depth. Having heard him before I was disappointed in this presentation as others he has given have been excellent.

There are too many benefits of the joint conference to list them all however I will say that this is the way to go in the future. The opportunity for board and staff to be together to learn and celebrate is of utmost importance.

20. This joint-conference was an excellent opportunity to share in professional development and strengthen relationships between three key partners in Education. With bylaw changes, the AGM portion of the conference (for Trustees) could run more efficiently in the

future. I missed the breakout sessions and think it would allow for more dialogue and collaboration between the 3 organizations if there were some planned break-out sessions for all attendees. LEADS & SASBO attended a Lean session on Monday morning. Trustees would have benefitted from this as well.

- 21. Well done, could be healthier options for breakfast, lunch and suppers are always good but breakfast seems quite fatty. Yogurt and more fruit even for breaks. Best regards.
- 22. As a Conseil scolaire fransaskois member and first time attendee, the sunday evening was not only a total loss, but proved to be a humiliating experience.

Since there was no meeting space for the Conseil, my colleague, Joe Poirier and I decided to attend the public group. At first we were greeted hospitably, and offered pizza and beer, but when we started to speak to each other in French, someone came from the front table and asked us if we were from the Conseil. We said we were. He then said that the gatherinig was for members of the Public sector only, and once the meeting would begin we would be asked to leave, or we could leave before the meeting began.

We then left.

- 23. Too much time between events. Maybe compact it into Monday to Wednesday, or Sunday to Tuesday. Boredom set in for some Board members leading to them leaving early, and missing some good stuff.
- 24. In order for Boards of Education to remain autonomous, elected representatives, we must meet collectively as school boards through our provincial association. While it is important to work collaboratively with our administrative partners, there is a fine line that must be maintained in order for Boards to uphold their representative status. Other than fiscally, I am not sure I see the benefit of this combined event. Boards need to use their voice by bringing forward more resolutions, this is our one area of influence collectively, and this conference is a time when our association should be reporting back on actions taken on resolutions made previously provide evidence of follow up and demonstrate what the action plan is going forward.

Organization of this year's event left much to be desired and could have been accomplished in half the allotted time. Four days is a bit much to ask of Trustees who must take time away from families and employers in order to attend, and a tremendous cost for lodging, meals and parking. And four days, including a Sunday, is too much time away from the office and families for Directors and CFOs. Two days max is all that should be required and that I am able to give up for an event of this nature. Engagement of delegates was lost due to an ineffective schedule.

The open discussion time for resolutions in our constituency groups on Monday morning was a complete waste of time. We sat in our regular Board groups and had gone through everything within about 30 minutes. There was no real collaborative discussion between Boards within the constituency groups, so what was the point of this? We could have all done this at our own Board meetings prior to the conference. Some sort of structured/facilitated discussion would have been helpful.

Dr. Huff had an interesting presentation. My personal preference is for Canadian speakers, not American.

With the student panel discussion, I would suggest one student per division in order to get a broader range of perspective from these young people.

A comment on the governance presentation by Mr. Brown and Mr. Perrins - I thought we would be reviewing recommendations from the report, not doing Board PD by going over basic governance structure concepts; very disappointing.

It seems like everyone likes to leave at noon and the room empties maybe try to accommodate people that have to leave at noon. Having closing at noon even if we have to start maybe 1/2 day earlier. Talking to some they sort of felt the same way, Other than those comments we always enjoy our conversations and dialogue. Your speakers, we always enjoy. Thank you for all you do.
- 42. The conference could occur annually, provided that there is ample time for the sectors to meet and discuss things that are relevant to their sector. I feel that if the conference could occur when there are not conflicting meetings for one of the parties. it could occur annually. The opportunity for Divisions to team build was fantastic, however I am not sure how many Boards capitalized on that.

The suppers were most excellent, the lunches were good and the breakfasts were not worth serving.

- 68. Potical panel I would have enjoyed both sides of the house and a little more by way of specifics from the Leaders of these Ministries
  - Student panel was helpful. How about asking a couple average or perhaps alienated students to join us and speak to us. The cream of the crop are good too but......
- 69. Very well organized. The LEADS module I attended was very well done and I learned a lot! The joint sessions created great dialogue between ourselves and our board members. It was a great experience! Thank you!
- 70. Too much free time for Trustees in the SSBA portion (largely due to no elections so maybe not much you can do about that).
  - Also overall a bit long by the time Wed afternoon presentations were made a lot of people had left or were disengaged. That afternoon was not applicable to most SASBO members other than an awareness as to why Aboriginal Education/achievement is a priority in the ESSP.
- 71. The speakers and panels were well chosen and will provide food for thought to local boards. I believe the AGM was well attended and was successful because boards had such things as the budget very earlier to study and to be prepared to discuss the resolutions with care and attention. The most frustrating experience was the AGM time lines. Of course, one realizes extra time had to be allocated for resolutions and elections but the amount of down time for both Directors and Board Members was a way too long. Please, consider making changes to the AGM agenda to improve efficiency of time.
- 72. The breaks were far too long there is no need for a 40 min coffee break.
- 73. Should have activities that mix members from different organizations discussing issues of concern to all organizations. There was too much down time in the SSBA part of the event. The session from Kir Ratz was very poor for this type of event. The student panel was excellent and more could have been done with students. Too long going from Sunday

evening all the way to Wednesday afternoon.

- 74. I believe a joint conference should occur but that it needs to be on at least a 5 year rotation. It was good to have a conference together but the feedback I received from my staff was that it really did not feel like a joint conference. Many felt like we were invited to take part in the SSBA conference and that it did not have a joint feel.
- 75. i think the concept was great but it was an opportunity lost. you had all these people in the same room but they didn't get a chance to talk about what was important to them or to find common ground. we could have spent very valuable time talking with others across the province that have the same questions and concerns and who also have answers. sorry i can't support this if it continues in this fashion. our time and money is too valuable to spend in a sessions like Kim Ratz offered. thanks for your efforts in planning this and as i said the concept is great but the true opportunity and value were lost. thanks.
- 76. Excellent event. Hard to make everything highly relevant for everyone all the time. Great mixture and I definitely benefited from my time.

- 77. It is difficult to create a joint conference program that will provide meet the needs of the 3 groups.
- 78. I attended the HR module with Dean Biesenthal and Kyle McIntyre which was excellent
- 79. Time for collaboration around focus issue or concerns.
- 80. Opportunity for all involved with the education of our children to come together and collaborate.
- 81. There was a significant amount of time that could have been better used.

The governance and operations session was not very inspiring at all.

Again, low attendance at this session provides an indication of the quality of the presentation.

Kim Ratz's session had to be extended to fill time. The anticipated time allocation for the prior items was about 40 minutes too long.

The presentation was just okay.

Wednesday's attendance at sessions was poor - attendance declined as the day proceeded.

- 82. I thought that this was a good first attempt, and that the general idea was excellent. If the LEADS sessions would have been at TCU place on Monday and Tuesday morning, there would have been additional opportunities to make connections between members of different organizations. This might have allowed the conference to shave off a day at the end. There were many email contacts from SSBA and from LEADS prior to the conference, and I thought it might have been easier if there was one entity responsible for doing all of the conference communication. Thanks to the committee for your work!
- 83. I believe the concept of joining our conferences into one and the intent were right. However it was very challenging to have so many people out of the system for the same three days. Because of this, we chose to leave some folks back and therefore, they missed their annual conferences. I also think it is difficult to find speakers that pertain to the full mix of people. Many left early on Wednesday as they believed the content did not pertain

to them - mostly SASBO folks I believe. And Directors had to choose between the AGM for SSBA and our own association and short courses. Both are important and valuable processes. While I believe the intent was right, I'm not entirely sure it was as successful as planned with so many challenging factors. I do appreciate the work to pull it together and the attempt to provide an opportunity for networking.

84. As SSBA members, our board felt that time was not used wisely for us. There were too many periods of down time and the conference was spread out over too many days, resulting in extra expenses for our board. Also, having nearly all senior staff out of the office for three consecutive working days wasn't optimal.

On the plus side, I really enjoyed the opportunity to discuss resolutions in small groups prior to voting on them. It was at these discussions that I realized how many members didn't clearly understand the resolutions or the implications. I believe the discussion that followed helped to clear up some misconceptions. Without this open discussion, some members would likely have voted based on misunderstandings. I believe that a joint conference is a huge amount of work and very difficult to coordinate properly. Unless the scheduling issues can be resolved, I don't think a joint conference is beneficial for trustees.

- 85. Too many coffee breaks and way too much time.
- 86. It was uncomfortably cold in the TCU most of the time. It was distracting from the meetings
- 87. I appreciate the intent of the conference however I struggle with the draw of folks from our school division. I also felt that at times sessions did not appeal to the broad audience that was in attendance.
- 88. Monday was a poorly planned day with so much free time. SSBA AGM could have been finished in one day. Trustees that are attending these functions have other jobs we need to feel that our time is valued. With the joint conference there were no SASBO or LEADS people left in our School Divisions.
- 89. I think it is very important that we work collaboratively on educational issues and opportunities. It sends a very powerful message to other sectors (Child and Family Agenda) that we are united and focused on putting the Student First.
- 90. Perhaps too much down time. This joint conference could be that cause. Three school divisions presented to an empty room. Not fair to their effort and time . Need something to keep people there.

Suggest that dynamic presentation at the last hour, perhaps Minister or Premier type of presenter

91. I missed the education breakout sessions on insurance, technology, other division successes, and treaty education ideas.

I thought the venue, and food were excellent as always. The elections, resolutions, and our SSBA portion could have been done in 1/2 day. It was a total WASTE of my time other than the banquet, CJ Huff and the comedian.

If we want to follow the ministry directives to increase grad rates, do treaty education, and increase math, reading and writing in our students, maybe the SSBA should be providing ideas and success stories along those lines. We had the 3 groups at the conference that could have changed student lives, and it was a FAIL on the content.

I left early as a trustee I could not waste more taxpayer dollars sitting at a convention that was of no use to me - 9 resolutions, seriously!!!! I am also self employed and was not making any money sitting there.

Maybe you should have some input from boards on planning the convention. I hope the CSBA national convention is better than this provincial one. VERY DISAPPOINTED and I have been on the board over 9 years - worst one yet.

- 92. Concept is strong. Intersectoral work is key to our shared success with student achievement. The lag time between sessions was too long. For a first attempt it demonstrates potential.
- 93. I found the conference to be fair in length although there were many that found it to be too long. Presenters were solid and the sessions were good. However, I still believe, even at a joint conference, that there should hospitality suites as they provide for a great opportunity for networking.
- 94. I felt that there was too much down time at this conference. 4 days should have been accommodated in 3 days. it would seem the school boards put out a lot of money for the Sunday which could have fit into Monday, or just a shuffle in different order to accommodate elections.

Also I was very disappointed at the banquet to see the disrespect of people who were in the procession to see them carrying in alcoholic drinks in hand. I feel as though it was poor in taste on their part to do so. this is not a show, when walking in behind Minestry, and legislated officials it shows disrespect.

the breakfast meals NEED to have a better balance diet to those who dont want deep fried or pastries. we Need to have fruit/yogurts/granolas or muffins, not desert pastries! these are my opinions.

- 95. This could have been leaned out to 1.5 days at a significantly reduced cost to school divisions. I should not have been forced to skip my mandated LEADS modules so I could provide my Director duties to my Board. Keeping track of three agendas was very confusing and so will be the resulting financial tracking as it overlaps with governance and administration.RATZ was an insult to LEADS members who understand leadership. His presentation was 20 years old and not his work in several areas. Gambling is not an optic we should profile for education..in my mind sends the wrong message to the people we lead.
- 96. Certainly the organizers of this event need to be congratulated for their work, effort and vision.

Overall the conference was good. I think what prevented it from being very good or excellent was the spacing and timing of speakers. There seemed to be too much down time. I think a one day joint conference would have been sufficient.

I recognize this is brand new and there are kinks to work out.

I appreciate the planning and organizing that went in to this event. Certainly there was a great deal of work which was done to pull this off.

97. Understanding that time allotment for agenda items can be a difficult thing to judge when dealing with election items and resolution items, it is still important to make sure those in attendance feel they have spent their time worthy of important educational issues.

Two items that SSBA could consider as fill ins are: Past resolutions update, and/or division presentations. Both these areas of information could be in printed form and ready to present where time alloted. If time did not allow for all to be presented, attendees have the printed versions to fall back on.

Too much down time left many members in attendance feeling that time was wasted or could have been better spent. The information that was presented was interesting, important, and relevant. I believe with some thought and some input, SSBA can figure a way to add to the conference by having fill in material prepared.

- 98. There were too many dead spots in the conference. Monday afternoon and Tuesday morning were very slow. There needs to be some back up planning in the case there is the lull that was very apparent due to the lack of an election and few resolutions. I realize that this was the first Joint conference and that planning on speculalation is very often not easy bit I personally could not see any advantage to having a joint conference. We could have easily started the conference on Monday at noon, other than the fact that we need 24 hours for the election process. I was disappointed at the amount of time where there really was nothing to do except visit and drink coffee. I also think that the Trade show could have stated earlier as a lot of peopl just disappeared because there was a 2 hour dead spot between the end of sessions and the start of the trade show on Tuesday.
- 99. Thanks to everyone for all the hard work. I enjoyed it all. The only complaint I heard was that there was too much "free" time. Also, that there wasn't an annual report given.

- 101. I was involved in taking the ten hour module training on Finance and I only joined the joint conference at noon on Tuesday. When I arrived just before noon on Tuesday it appeared as if there was no formal activity taking place. In conversation with other Directors who had attended the SSBA convention from the beginning they indicated that on Tuesday morning nothing formal occurred. There were also some extra long coffee breaks and lunch breaks. The timing of the conference sessions appeared to be off. Perhaps trying to have a joint conference caused the timing of sessions difficult to schedule.
- 102. Clearer communication for LEADS members as to the agenda of the joint conference. Did not know location and time until registering. Beforehand we were only given the one page pamphlet with speakers on it, no other details. Thank you!

- 106. Although the idea of a joint conference is a good one, I am not sure a joint conference adequately meets the needs of members of the various organizations. I checked "No Joint Conference" because there is no choice for holding the joint conference every four years-I would not want to see it anymore often than every four years.

Thank you to those who worked hard in support of the conference. I found the Leads module I participated in to be very good. Also, I certainly enjoyed the conference keynote.

- 107. I would suggest that the conference start with a robust agenda on Sunday afternoon and end on Tuesday night with the awards banquet.
- 108. I didn't see the need for the stretch of 3 days, as most of us were already donating time from our Boards and regular employment, I failed to see any benefit for the Trade Show which was more for Administration rather than trustees, I found the beef on the bun very lacking in any sustenance after a very long day. Overall, I think this was the worst conference, I have attended. Although the concept of a joint conference is a good one, I think perhaps in the Spring it would be a better time. I did appreciate the extra time to discuss the resolutions but I failed to see any benefit in separating Urban from Rural, the concept defeats the purpose of dialogue and learning. Rather than panels, I think it would be more efficient to have trustees work with each other and do facilitated round table discussion on items that are affecting our boards presently. i.e. facilities, bussing, classrooms sizes, funding etc.

Because president and vice were acclaimed, losts of extra time since no runoff speeches needed created a time void but I don't know how you could fill that. Organizing committee did a good job.
