- 5. It was great to have Resolutions included in the Spring Assembly a welcome change.
  - Generally, however, there is not enough opportunity for membership voice at SSBA events. The risk in this is that the executive (or committees representing all Trustees) do not get the valuable input they need to truly be the voice of all school boards. The exec. relying on a smaller & smaller group to inform its actions (chairs council) and runs the risk of alienating the general membership. More opportunity for sharing & discussion between Boards and w the Executive @ SSBA events strengthen our Association, improve the format & efficacy of Assemblies.
- 6. Mixed groups at the networking session is essential so that trustees from different boards have the opportunity to share and hear alternate perspectives. Great work.
- 7. The overall event was good however I think in the future if something could be done to mix up the room so that members are not sitting with there own board. This would stimulate some good conversation. Maybe having an assigned number on your name tag that will put you to a certain table assigned to you. This would also work for the fall assembly. Just a suggestion as some members will not do it on their own, that little extra push will go along way.

And some of the conversations we had in other sessions lead to suggestions for action and direction for the Executive to take. There was no opportunity to talk about what direction the Boards wanted taken. The network meetings are always good, but in the past we have met before topics are brought to the assembly, to have feedback (like the resolutions), from our specific networks.
